- The rates are subject to change without notice.
 - The rates are ZAR (South African Rand)
- The Clients reservation will be effected upon receiving a signed copy of these terms & conditions completed reservation form and the payment of the deposit.
 - Take note that we are not vat registered.
- The venue is only available on the day the venue has been reserved. Should you, or your representative, require prior entry for setup, or post entry for breakdown, please communicate with reservations.
 - Cancellations will only be accepted by email to reservations@bongame.co.za
 - No verbal cancellations will be accepted.
- A non-refundable deposit of 50% to secure your provisional booking, is required. • We will hold the booking on a provisional basis for seven (7) days, until a signed copy of this agreement is received
- Provisional bookings will be released without notification, should you fail to make payment of the deposit and provide Bon Game Private Reserve with the necessary documentation as contemplated above, within the said seven (7) day period.
- An additional breakage deposit fee of R5000 will be added to the quote, this includes, but not limited to, glassware, cutlery and crockery. The deposit will be refunded within two (2) weeks of the event date.

CANCELLATION POLICY

The following cancellation fee will be charged by Bon Game Private Reserve to the Client, in the event of cancellation of any advance reservation or booking:

- 30 Days prior to event a 25% cancellation fee will be levied on the full value of the quotation.
- 21 Days prior to event a 65% cancellation fee will be levied on the full value of the quotation.
- 14 Days prior to event a 100% cancellation fee will be levied on the full value of the quotation.

THE PREMISES

1. The premises shall always be under the control of the Bon Game Private Reserve which reserves the right to impose any terms and conditions in addition to those contained herein, as it may deem necessary, in order to ensure that the rights of other visitors to Bon Game Private Reserve, the neighbors and others are respected.
2. The Venue Hire is restricted to Bon Game Private Reserve only.
3. The client's arrangements for music should be discussed with and approved by Bon Game Private Reserve. Any request by Bon Game Private Reserve Management for music volume levels to be reduced must be complied with. If in the opinion of Bon Game Private Reserve Management, the pre agreed noise levels are exceeded, the full breakage deposit of R5000 will be retained.
4. The Client and Bon Game Private Reserve Management should meet one week prior to the function to discuss procedures for the event as well as special requests. All role players should be present to be involved in the process.
5. The function holder must ensure that the premises are returned to Bon Game Private Reserve in the same good order and condition in which they were found.
6. Bon Game Private Reserve will not be held responsible for any reason whatsoever for the non-functioning of any equipment brought onto the premises by the function holder.
7. The function holder will be responsible and liable for any damage or loss caused to Bon Game Private Reserve by any of the sub- contractors hired for the function.
8. Bon Game Private Reserve and/or its staff will under no circumstances be liable for the loss, damage and/or theft of any of the subcontractor's equipment or loss or damage to any property of the guest attending the function.
9. All functions must end by time agreed upon. Should functions not end by time prior agreed on, Bon Game Private Reserve reserves the right to retain the full breakage deposit.
10. Maximum numbers will always be adhered to. Failure to adhere to maximum numbers will result in the function being cancelled.
11. Final numbers must be confirmed ten (10) days before your function.
12. All refuse must be removed by the function holder immediately after the function.
13. All equipment brought onto the premises by the Client or any of its contractors must be removed from the premises within 24 hours.
14. Please note that setting up the venue remains the Client's responsibility.
15. The breakage deposit paid by the function holder will be forfeited should any of these rules not be strictly adhered to by the function holder, its sub-contractors and/or its guests.

YOU HEREBY AGREE, AS A CONDITION OF YOUR OCCUPATION OF THE PREMISES THAT BON GAME PRIVATE RESERVE AND THE OWNER, MANAGER AND/OR OPERATOR OF THE PREMISES AND THEIR AFFILIATES AND RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES, AGENTS AND REPRESENTATIVES SHALL NOT BE RESPONSIBLE OR LIABLE FOR ANY ACCIDENT OR ANY INJURY OR DEATH OF ANY PERSON OR THE LOSS OR DESTRUCTION OF OR DAMAGE TO ANY PROPERTY, WHETHER ARISING FROM FIRE, THEFT OR ANY OTHER CAUSE WHATSOEVER AND BY WHOMSOEVER CAUSED OR ARISING FROM THE NEGLIGENCE OR WRONGFUL ACTS OR OMISSIONS OF BON GAME PRIVATE RESERVE. BREACH

- 1. The terms and conditions of this agreement are all deemed to be material and should the function holder and/or its subcontractors be in breach of any of these terms and conditions, Bon Game Private Reserve will be entitled to: or cancel the function forthwith; or claim the full hire charges and retain the breakage deposit; or claim any damages it may have suffered because of the breach.
- 2. The interest payable to Bon Game Private Reserve for any money outstanding will be calculated at the prime overdraft rate.

SEVERABILITY

If any particular provision and/or term of this Agreement is found to be defective or unenforceable or is cancelled for any reason (whether by any competent Court or otherwise) then the remaining provisions and/or terms shall continue to be of full force and effect. Each provision and/or term of this Agreement shall accordingly be construed as entirely separate and separately enforceable in the widest sense from the other provisions and/or terms hereof.

COUNTERPARTS

This Agreement may be entered into any number of counterparts and by the Parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.

WHOLE AGREEMENT
